#### **Terry Fox Fundraiser Celebration Assembly**

This year the Mills Haven Community raised \$11,000 for the Terry Fox Foundation! We had a great day honouring Terry Fox and all those whom we walk for on September 23. To celebrate the tremendous fundraising efforts that occurred we will be having an assembly on October 28 at @2:15 PM where 11 staff members will have a pie thrown at them (1 pie for every \$1000 raised). All parents are invited to join us for this celebration.

#### Budget

The budget for the 2022-2023 School Year has been submitted. It is based on an enrollment of 459 students for a total of \$3,051011. Staffing accounts for 94.72% of the budget. We received some extra funds due to our increased enrollment from the spring and also some Learning Loss Funding. These extra funds will go towards a part-time intervention teacher to support small group instruction and a part-time education assistant to support some coded students.

#### October 7 PL Day

On October 7 all the teachers at Mills Haven participated in a Professional Learning Day focusing on our School Education Plan, PowerTeacher Pro and Collaborative Team Meetings. Our next Professional Learning Day will be on January 30, 2023, where all staff will participate in a beading activity with our Metis Artist in Residence, Connie Kulhavy.

#### **School Fees**

School fee information for the 2022-23 school year is now posted on the PowerSchool Parent Portal. All fees are due within 30 days of being posted. This year at Mills Haven, the field trip fees are posted for the entire year. Any field trip that a class takes this year is budgeted for in the fees that are posted.

#### **Christmas Concert**

This year we are delighted to have an in person Christmas Concert again. The concert will be on December 8, 2022 at The Park Church. The Kindergarten-Grade 2 performance will be at 6:30 PM and the Grade 3-6 performance will be at 7:15PM. More information to follow from Mr. Funke.

#### **Assurance Review**

The annual Assurance Review will take place in the first week of December. This is an opportunity for school trustees to hear what is happening in schools. #### **TRUSTEE REMUNERATION: 2022-23**

The Board approved the trustee remuneration for the 2022-23 school year. Rates will increase by 1.756 per cent, effective Sept. 1, 2022. The rate increase aligns with the pay increase approved for all EIPS classified employees in spring 2022.

#### **ADVOCACY COMMITTEE**

The Board received for information a report from the Advocacy Committee meeting held on August 31. Topics discussed: the committee's strategic plan, advocacy focus areas, *EIPS Quarterly Update*, and launching a newsletter to engage the school community about Board advocacy efforts.

#### FACILITY SERVICES: 2021-22 SUMMER PROJECTS UPDATE

The Board received for information an update on Facility Services' summer projects in 2022. Throughout the summer months, Facility Services oversaw a total of 367 summer projects, including Infrastructure, Maintenance and Renewal (IMR), Capital Maintenance and Renewal, and additional projects across the Division—98 per cent of which are complete. ### **CAREGIVER EDUCATION SERIES: October**

Alberta Health Services is hosting a series of virtual caregiver information sessions focused on ways to support students' mental health. The sessions are free and geared toward parents, caregivers, teachers and community members who want to learn more about challenges impacting children and adolescents. #### NEW CURRICULUM AND ASSESSMENT TOOLS

Associate Superintendent Sandra Stoddard spoke about resources the Division has created for the new curriculum and the assessment tools being used for the school year.

#### New Curriculum:

The Board allocated funds to continue our Division's efforts around building teacher capacity to successfully implement the new curriculum in the 2022-23 school year. A group of seven teachers were seconded to develop high quality unit plans assessments and resources in English Language Arts (K-3), Mathematics (K-3) and Physical Education and Wellness (K-6). This team will continue developing resources and offering professional learning opportunities for teachers to collaborate and refine their own planning processes for the new curriculum—using both Board and Alberta Education resources allocated for the 2022-23 school year. Additionally, in the summer, a group of French Immersion teachers worked to ensure EIPS' newly developed resources were translated into French.

#### **Assessment Tools:**

Alberta's government has introduced mandatory literacy and numeracy screening assessments for all students in grades 1 to 3, beginning this school year. EIPS will also assessing current Grade 4 students to support the Division's application for extended learning loss funding from the province. All EIPS students, grades 1-4, will participate in these assessments—grades 2-4 students started in September, Grade 1 students start in January 2023. Schools will use results of the assessments, and STAR results, to plan and guide intervention programming throughout the school year, as needed.
